1-Day Notice: Migration of Morningstar Multi-Asset High Income and US Bond Market Yield-Optimized Indexes to In-House Calculation Platform

As [previously announced](#), Morningstar Indexes will be bringing the calculation and publication of the below indexes to our single in-house platform, Cirrus. Morningstar Indexes plans to migrate these indexes from the current calculation agent, ICE Data Services onto our platform **after the close of business on September 11, 2026**. This is your 1-day notice.

The parallel test files are now available in your Morningstar SFTP test folder, and we strongly encourage clients to review these files. There are changes to the file names, file formats, and file content, which are explained in more detail below.

Timeline:

Timeframe	Activity
June 11, 2026	Client Parallel Production Testing for EOD files. We will turn on parallel deliveries for all clients and all indexes, from June 11, 2026 onwards, for a period of at least 3 months in your Morningstar SFTP.
September 11, 2026	Impacted indexes will be migrated to the Cirrus platform. September 11, 2026 is the last day that you will receive both formats. From Monday, September 14 you will only receive the Cirrus format files to your live SFTP folder directory.

We will closely monitor testing results and client feedback before proceeding.

File name changes and source:

Test files will be delivered to your Morningstar SFTP account **/test** folder. After the migration, you will no longer be able to receive files directly from NYSE and **will receive the new files to your SFTP account /data folder.**

New file names will follow the Morningstar Cirrus file naming convention: MSTAR_Index-Name_PortfolioID_FileType_yyyymmdd.csv.

Real-time dissemination:

We will be consolidating the real-time dissemination from NYSE GIDs to Cboe MSTAR channel for the below tickers:

BMYOP – Morningstar US Bond Market Yield-Optimized PR

BMYOT – Morningstar US Bond Market Yield-Optimized TR

MAHIP – Morningstar Multi-Asset High Income PR

MAHIT – Morningstar Multi-Asset High Income TR

As part of external parallel testing, Morningstar will be disseminating test values via the Cboe certification environment under the above symbols starting August 17, 2026. Clients are encouraged to start testing the real-time values to ensure access continuity prior to the cutover.

NYSE GIDs will be disseminate the final tick on September 11, 2026. Cboe MSTAR channel will be the official channel for real-time time dissemination for these instruments from September 14, 2026 onwards.

Index data changes and methodology:

We expect updates to index data sources, corporate action methodology, and index maintenance procedures, resulting in minor index level differences. For more information on the expected differences, please contact your Implementation Manager.
